This Act may be cited as the Sharebrokers Amendment Act 1957, and shall be read together with and deemed part of the

The references to a "District Court Judge" and a "District Court" were substituted, as from 1 April 1980, for references to a "Magistrate" and a "Magistrate's Court" by section 18(2) District Courts Amendment Act 1979 (1979 No 125).
