

## State-Owned Enterprises (Kordia Group Limited) Order 2007

### Preamble

At Wellington this 19th day of February 2007

Pursuant to section 30A of the State-Owned Enterprises Act 1986, His Excellency the Governor-General makes the following order, acting—

- (a) on the advice and with the consent of the Executive Council; and
- (b) on the recommendation of the Minister for State Owned Enterprises, who is satisfied that—
  - (i) the name of the State enterprise known as Transmission Holdings Limited has been changed to Kordia Group Limited; and
  - (ii) a certificate of incorporation recording that change of name, dated 17 November 2006, has been issued to that State enterprise under section 23(3)(b) of the Companies Act 1993.

**1 Title**

This order is the State-Owned Enterprises (Kordia Group Limited) Order 2007.

**2 Commencement**

This order comes into force 28 days after the date of its notification in the *Gazette*.

**3 Official Information Act 1982 amended**

- (1) This clause amends the Official Information Act 1982.
- (2) Schedule 1 is amended by—
  - (a) omitting the item “Transmission Holdings Limited” ;  
and
  - (b) inserting the item “Kordia Group Limited” in its appropriate alphabetical order.

**4 Ombudsmen Act 1975 amended**

- (1) This clause amends the Ombudsmen Act 1975.
- (2) Part 2 of Schedule 1 is amended by—
  - (a) omitting the item “Transmission Holdings Limited” ;  
and
  - (b) inserting the item “Kordia Group Limited” in its appropriate alphabetical order.

**5 State-Owned Enterprises Act 1986 amended**

- (1) This clause amends the State-Owned Enterprises Act 1986.
- (2) Schedule 1 is amended by—
  - (a) omitting the item “Transmission Holdings Limited” ;  
and
  - (b) inserting the item “Kordia Group Limited” in its appropriate alphabetical order.
- (3) Schedule 2 is amended by—
  - (a) omitting the item “Transmission Holdings Limited” ;  
and
  - (b) inserting the item “Kordia Group Limited” in its appropriate alphabetical order.

**6 Television New Zealand Act 2003 amended**

- (1) This clause amends the Television New Zealand Act 2003.
- (2) The definition of **THL** in section 4 is amended by omitting “Transmission Holdings Limited” and substituting “Kordia Group Limited (formerly known as Transmission Holdings Limited)”.

**Explanatory note**

*This note is not part of the order, but is intended to indicate its general effect.*

This order, which comes into force 28 days after its notification in the *Gazette*, omits the references in 4 Acts to Transmission Holdings Limited and replaces them with references to Kordia Group Limited. This is because the State enterprise formerly known as Transmission Holdings Limited has changed its name to Kordia Group Limited. Under section 30A of the State-Owned Enterprises Act 1986, when a State enterprise changes its name, enactments may be amended by Order in Council to reflect that name change.
