Regulations

- 1 Title**
These regulations are the Health Entitlement Cards Amendment Regulations 2013.
- 2 Commencement**
These regulations come into force on 1 April 2013.
- 3 Principal regulations**
These regulations amend the Health Entitlement Cards Regulations 1993 (the **principal regulations**).
- 4 Regulation 8 amended (Eligibility for community services cards)**
- (1) In regulation 8(5)(a), replace “\$24,894” with “\$25,046”.
 - (2) In regulation 8(5)(b), replace “\$26,393” with “\$26,554”.
 - (3) In regulation 8(5)(c), replace “\$39,423” with “\$39,664”.
 - (4) In regulation 8(6)(a), replace “\$47,597” with “\$47,888”.
 - (5) In regulation 8(6)(b), replace “\$57,640” with “\$57,992”.
 - (6) In regulation 8(6)(c), replace “\$65,627” with “\$66,028”.
 - (7) In regulation 8(6)(d), replace “\$73,450” with “\$73,899”.
 - (8) In regulation 8(6)(e), replace “\$82,193 for the first 6 people, plus a further \$7,703” with “\$82,695 for the first 6 people, plus a further \$7,750”.

5 Consequential revocation

The Health Entitlement Cards Amendment Regulations 2012 (SR 2012/16) are revoked.

Explanatory note

This note is not part of the regulations, but is intended to indicate their general effect.

These regulations, which come into force on 1 April 2013, amend the Health Entitlement Cards Regulations 1993.

The amendments raise the income entitlement thresholds that are used to determine a person's eligibility for a community services card. These increases reflect a 0.61% increase in the New Zealand Consumers Price Index from the December 2011 quarter to the December 2012 quarter (calculated for all quarters using the CPI All Groups excluding cigarettes and other tobacco products).
