Regulations

1 Title

These regulations are the Electoral (Iwi Organisation and Other Māori Organisation) Regulations 2018.

2 Commencement

These regulations come into force on 26 October 2018.

3 Interpretation

For the purposes of sections 111A to 111F of the Electoral Act 1993, **iwi organisation and other Māori organisation** means any organisation listed in the Schedule.

4 Revocation

The Electoral (Iwi Organisation and Other Māori Organisation) Regulations 2012 (SR 2012/3) are revoked.

Notes

1 *General*

This is a consolidation of the Electoral (Iwi Organisation and Other Māori Organisation) Regulations 2018 that incorporates the amendments made to the legislation so that it shows the law as at its stated date.

2 *Legal status*
