Order

1 Title

This order is the Rates Rebate (Specified Amounts) Order 2023.

2 Commencement

This order comes into force on 1 July 2023.

3 Principal Act

Clause 4 amends the Rates Rebate Act 1973.

4 Section 3 amended (Rates rebate)

- (1) In section 3(1)(a)(ii), replace “\$28,080” with “\$30,100”.
- (2) In section 3(1)(b), replace “\$700” with “\$750”.

5 Revocation

The Rates Rebate (Specified Amounts) Order 2022 (SL 2022/169) is revoked.

6 Saving

A ratepayer’s entitlement to a rebate for a rating year ending before 1 July 2023, and the amount (if any) of that rebate, must be determined as if this order had not been made.

Explanatory note

This note is not part of the order, but is intended to indicate its general effect.

This order, which comes into force on 1 July 2023, amends section 3(1) of the Rates Rebate Act 1973. That section provides for a rates rebate for low-income home owners.

This order—

- increases the income threshold for a rates rebate from \$28,080 to \$30,100; and
- increases the maximum rates rebate from \$700 to \$750.

Notes

1 *General*

This is a consolidation of the Rates Rebate (Specified Amounts) Order 2023 that incorporates the amendments made to the legislation so that it shows the law as at its stated date.

2 *Legal status*

A consolidation is taken to correctly state, as at its stated date, the law enacted or made by the legislation consolidated and by the amendments. This presumption applies unless the contrary is shown.
